2. There is in addition a large number of potential claims for vehicles but it has not been possible to assess the quantity or the value as most were removed very promptly from the scenes of damage. The Agency will, nevertheless, ensure that all vehicle claims are handled expeditiously and that motor engineers visit the scenes or inspect the damaged vehicles as quickly as possible. The Agency will provide a report on damage to vehicles when the full figures are available in a few days.

3. I am pleased to be able to report that the Agency's out-of-hours arrangements operated satisfactorily throughout the holiday weekend. Loss adjusters were appointed to visit every site of property damage reported by



the RUC, the media or by members of the public. Initial visits all took place within the stipulated 24 hours with most taking place within 12 hours. The Agency's experience is that prompt attention of this kind is vital in reassuring traumatised victims and helping them start the rebuilding process as quickly as possible.

### **Estimated Final Cost**

4. It would be the Agency's estimate that the final cost of compensation for the nights of 11/12, 12/13 and 13/14 July will be at least £10 million. This is in addition to the £6 million estimated for the nights of 9/10 and 10/11 July put forward in my earlier submission. When final estimates are at hand the Agency will draw up figures showing the anticipated compensation expenditure profile.
