Meanwhile, the Quinn family have also welcomed the report.

Former Sinn Fein councillor and family spokesman, Jim McAllister told U105 the report confirmed much of what they had said from the start:

"We actually made it clear from the very start that we didn`t believe that the murder was santioned by the IRA Army Counil, or the IRA leadership.

From day one we said it was local south Armagh business. We also stressed it was due to lack of respect to leading figures in area who think they are entitled to respect for past glories, if you like.

The report actually goes into that in some detail. It clears the leadership. We expected that anyway."
