AT TODAY'S MEETING IT WAS REPORTED THAT ARMY PERSONNEL WERE UNLAWFULLY TAKING PASSES ISSUED BY THE U.V.C TO PERSONS IN ESSENTIAL SERVICES.

THE COUNCIL VERY MUCH REGRET THIS INTERFERENCE WITH THE ARRANGEMENTS AIMED AT MAINTAINING ESSENTIAL SERVICES, BUT NEVERTHELESS ARE FORCED BECAUSE OF THIS TO SUSPEND AS FROM MIDNIGHT ON FRIDAY ALL EXISTING PASSES.

NEW OR VARIED PASS ARRANGEMENTS ARE BEING CONSIDERED.

BAKERIES, DAIRIES

THE COUNCIL REVIEWED THE ARRANGEMENT MADE FOR BAKERIES AND DAIRIES AND FELT THAT THEY WERE OPERATING SATISFACTORILY.

WE HAVE LEARNT, HOWEVER, THAT THE SECRETARY OF STATE HAS SAID THAT HE IS PREPARED ~~THE~~ TO STARVE THE PEOPLE AND THAT SPECIAL ARRANGEMENTS ARE BEING MADE TO FLY IN SUPPLIES OF BREAD FOR THE ARMY FROM NEXT WEEK ONWARDS.

SUPPORT

THE COUNCIL WISH TO THANK ALL THOSE IN THE COMMUNITY WHO ASSISTED THE COUNCIL IN THEIR EFFORTS TO ALLEVIATE HARDSHIP. THE GROWING SUPPORT IN THE COMMUNITY WAS MUCH APPRECIATED PARTICULARLY FROM THE FARMING COMMUNITY WHICH HAS HAD TO MAKE SUCH HEAVY SACRIFICES.

THE COUNCIL NOTED THAT THE RUAS HAD TO POSTPONE THEIR ANNUAL SHOW. IT WAS REGRETTED THAT THIS WAS NECESSARY BUT THE COUNCIL APPRECIATED THE RESPONSIBLE ATTITUDE OF THE SOCIETY, BECAUSE THE DECISION WOULD HELP THE COMMUNITY IN ITS PRESENT DIFFICULTIES. THE COUNCIL HOPE ALL EMPLOYERS AND OTHER ORGANISATIONS WOULD FOLLOW SUIT. THE COUNCIL HAS REVIEWED ALL SANCTIONS AT PRESENT IN OPERATION AND ADJUSTMENTS ARE BEING MADE TO ALLEVIATE HARDSHIP.

GAS SUPPLIES

BOTTLED GAS WILL BE MADE AVAILABLE THROUGH THE USUAL CHANNELS FOR DOMESTIC USE ONLY. THEY ALSO EMPHASIZED FOR SUPPLIERS NOT TO CONTRAVENE THE HOURS OF 2pm - 6pm. THE ARRANGEMENTS WITH WHOLESALERS FOR THE SUPPLIES TO SHOPS WILL BE REVIEWED WHERE SHOPS ARE OPEN OUTSIDE THE AUTHORISED HOURS.

PETROL AND OIL SUPPLIES

ALL EXISTING ARRANGEMENTS FOR THE SUPPLY OF OIL AND PETROL TO HOSPITALS AND MEDICAL SERVICES WERE REPORTED TO BE SATISFACTORY DESPITE THE MEDIA'S MISREPORTING OF THE SITUATION. THE OIL COMPANIES CONCERNED HAVE UNDERTAKEN TO NOMINATE SUPPLY POINTS THROUGHOUT THE COUNTRY FOR THE PROVISION OF PETROL TO DOCTORS, NURSES, AND VETERINARY SURGEONS. ARRANGEMENTS WERE ALSO MADE TO SEE THAT FARMERS ALSO OBTAINED THE ~~NECESSARIES~~ NECESSARY SUPPLIES OF FUEL FOR FARM PURPOSES.

POSTAL SERVICES

FOR THE INFORMATION OF THE PUBLIC THE WORKERS' OFFER WAS DECLINED ON THE BASIS THAT IF THE P.O. WORKERS CAME INTO WORK THEY WOULD HAVE TO HANDLE ALL THE MATTER OR NONE AT ALL.
