

The attahced is a statement made by Brid Rodgers to the RUC after the 12th July parade in Portadown this year. In it, Ms Rodgers questions the decision to allow the march through nationalist Garvahy. She accuses the marchers of openly flouting the RUC stipulation that there should be no provocative music. She states that she is of the view that this march should not be allowed through Garvahy in future.
