Ministerial Visits

To confirm:

- I have had an informal word with Martin Williams, as you requested. He emphasised that the British Ambassador's complaint to the Secretary to the Government was about lack of notice of the recent visit to Newry by the Tanaiste and the recent vist to Derry by Minister Higgins, not about any aspect of the visits themselves.
- It is our joint understanding that the procedure agreed for visits by the President and by the Taoiseach does not extend to Ministerial visits generally. Williams had seen the Ambassador's report of his conversation with the Secretary to the Government and thought the Ambassador did seem to want to extend the procedure.
- I said I understood that in the case of the visit of the Tanaiste to Newry to appear on the RTE programme "Questions and Answers", the decision had been made that day. In the case of Minister Higgins's visit to Derry, I recalled that both Williams and myself had in fact been present when it was agreed at the Arts Ministers' meeting on 3 December last that both Ministers would attend the Celtic Film and Television Festival in Derry (Michael Ancram had to pull out at the last minute). Williams said the Ambassador would have known this anyway from the report of the meeting.
- Neither of us see why it should be necessary to involve the Embassy in all Ministerial visits. Notice or confirmation of such visits has usually been given through the Secretariat in recent years, although detail of itineraries has often been left to the police channel. This has the advantage for the British of ensuring that the NIO is aware of arrangements at senior level.
- Williams said that his views were his own and were informal. He intends to consult within his system and come back to me on the matter. He mentioned that, as already suggested above, the Ambassador might have different ideas.
