STATISTICS ON NORTHERN IRELAND SECURITY ENVIRONMENT

1. Purpose

This paper seeks the agreement of NIO, RUC and HQNI in principle to the establishment of a common statistical data base and recommends that a statistical co-ordinating group be formed to take this forward.

2. Background

At a meeting of the Complaints Monitoring Group in March 1989 NIO Statistics Branch was tasked with reviewing the information available on various aspects of the Northern Ireland Security Environment. During the course of the review, which focussed on security incidents, Army activity and complaints and compensation claims arising from RUC/Army activity, NIO Statistics Branch held discussions with the major parties concerned. These discussions raised a number of anomalies with the information gathering/statistical field which this paper now highlights.

3. Security Incidents

NIO, RUC and HQNI have considerable interest in data on security incidents. Each organisation requires access to individual incident based information and aggregate statistics in order to respond to comments/queries on the security front and to assist in the formulation of policy. Daily situation reports and daily RUC duty officer's reports presently form the basis for this information.

4. At present two separate retrieval/statistical systems operate within RUC/HQNI. This duplication of effort leaves both the RUC and HQNI open to embarrassment if, as sometimes does happen despite strenuous efforts, the systems fail to agree with one another. In an effort to overcome this the review concluded that thought should be given to the development of a single information/statistical system to meet RUC, HQNI and NIO needs (at present the NIO does not have the benefit of such a system). A single system would not preclude each organisation incorporating information specific to its own requirements.

5. Pending the development of the above it was further suggested that for each aspect of the security situation either RUC or HQNI should be agreed upon as the definitive source. This would mean that at any one time only one source of data would be quoted publicly. This includes data (mostly from the RUC side) not looked at in the NIO Statistics Branch review. At the same time the review suggested that it would be helpful if the statistical records from the HQNI system could be copied to NIO Statistics Branch's computer. A list of the sort of data which it would be useful to hold on a common database is attached at Annex 'A'. (It will be important to update the 'database' regularly so that interrogation does not produce outdated figures).

6. Indications of Army Activity

Each time the Army carries out a detailed property, vehicle or route search, a Northern Ireland Search Report is completed. This information is held on computer but the primitive nature of the

present system means that the information can only be used for textual retrieval. It has no statistical capabilities. In order properly to utilise this information the review therefore suggests that the statistical data should be transferred to a more suitable computer, for example, such as the one operated by NIO Statistics Branch. If HQNI were to agree to this the review noted that the Army in turn could benefit from any consequent statistical summaries.

7. Complaints, Compensation and Civil Litigation

Complaints against the security forces which are investigated for disciplinary reasons can be a useful measure of dissatisfaction with security force activity. However, policy related complaints, compensation claims and civil litigations can also be important indicators of public concern. Accordingly the review suggested that a computerised statistical system which could take account of all types of complaints and compensation claims arising out of RUC/Army activity should be set up. This could be best achieved if each agency involved were to forward to NIO Statistics Branch a case based return of all claims/complaints received. Whilst the format of such a return would need a certain degree of standardisation, it could be tailored to suit the peculiarities of each of the various operational systems. In view of the information currently to hand the database is, in the initial stages at least, likely to concentrate on complaints and compensation claims arising out of Army activity rather than that of the police.

8. Complaints against the RUC

RUC and ICPC statistics are presently at variance with each other due to a difference in timing, presentation and coverage. It was noted that many cases took more than a year to process, and consequently data on complaints investigated was somewhat dated when it came to assessing current trends in type and volume of complaints. However, this situation could be reversed by (i) a more detailed analysis of the complaints received and (ii) the creation of a case based system, based on the records held by the RUC. The review noted that this would require close co-ordination between the RUC and other interested parties with the RUC taking the lead.

9. Recommendation

A steering group should be set up to develop and establish a common statistical database and the RUC, HQNI and NIO should work hand in hand to develop a common statistical/information system to the benefit of all concerned.
