## NI WOMEN' **POLITICAL FORUM: CONFERENCE ON ANTI-SECTARIANISM ON SATURDAY 27 SEPTEMBER 1997**

I am most grateful that Mr Worthington has agreed, given the unavailability of the Secretary of State, to open the NI Women's Political Forum (NIWPF) Conference on Anti-Sectarianism to be held at Hillsborough Castle between 10.00 am and 4.30 pm tomorrow.

2. The NIWPF is an umbrella group for women in the various political parties (and none), which is seeking to broaden its support and to encourage more women into NI politics. They are aware that the Minister's other commitments minimise the time that he can spend with them and are content that he will be able only to welcome the participants and formally open the Conference.

3. An outline Conference agenda is attached - Annex A. I am advised that there has been no difficulty filling the maximum number of participants allowed by Hillsborough's confines (120). The Minister's 'welcome' slot has been agreed for 11.00 am, to allow time to get all the participants into the Castle and to have coffee, etc, and should last no longer than 10 or 15 minutes. Some draft brief speaking notes are attached - Annex B. A short press release cleared with Information Services is also attached - Annex C. Finally, I attach - Annex D, for information only, a copy of the NIWPF's draft Constitution which was recently forwarded to me.

4. The Minister may also wish to note that on this occasion invitations did **not** issue to Sinn Fein because of reservations from the Loyalist parties, although it remains the intention of the NIWPF organising committee not to delay any longer than necessary an invitation to Sinn Fein women to join. Against that, I am advised that, for the first time, women from the UUP will be present. Some women from the media have been invited to participate in the Conference and the organisers will be inviting the press to cover the event, to which we have no objection.


5. I will be attending the Conference and a member of the Information Service will be on hand during the Minister's opening remarks. I trust that these arrangements are satisfactory.



# DRAFT SPEAKING NOTES FOR MR WORTHINGTON TO OPEN THE NIWPF CONFERENCE ON ANTI-SECTARIANISM

First, may I extend a very warm welcome to Hillsborough Castle to you all .

As you know, the Secretary of State had hoped to be with you this morning but, unfortunately, her diary does not now permit her to come along. She has asked me to pass on her apologies to you all. I should also mention that my own diary commitments mean I can only stay briefly with you. However, both the Secretary of State and myself look forward to receiving a report of the proceedings in due course.

I wish to congratulate you on two counts. First as a body of women active in NI politics from a wide cross-spectrum of political parties, and second, for choosing to look today in depth at sectarianism and how that might be tackled. Everyone has their part to play, and that includes the Government, in eradicating this from NI

society.

For those of you here on your first visit, I should say that Hillsborough Castle is also a Royal residence. The decor and furnishings therefore reflect that and the history of the building. I trust that no-one will take any offence from the surroundings nor indeed from my mentioning this fact to you this morning.

#### ANNEX D

#### **DRAFT CONSTITUTION FOR THE NIWP F**

- 1. There shall be a Northern Ireland Women's Political Forum established and known hereafter as the NIWPF.
  - 1.1. The Women's Political Forum shall act as an umbrella group for women in the various political parties.


#### 2. Aims and objectives

- 2.1. To raise the political consciousness of women.
- 2.2. To highlight women within politics.
- 2.3. To foster good relations between women of the various political parties.
- 2.4. To achieve the maximum degree of co-operation on all political issues between the various parties.
- 2.5. To give expression to issues which impact upon women such as social, economic and equality issues.
- 2.6. To empower women within their individual parties by the exchange of information, the giving of support and boosting confidence.
- 2.7. To devise such programmes of work which enable women within the community to understand the political process and structures.

#### 3. Structure of the NIWP F

- 3.1. The forum shall comprise of women nominated from the individual parties affiliated.
- 3.2. Each party shall be entitled to a maximum of 4 representatives from each constituent party.
- 3.3. The forum will consist of the following officerships:
  - a) A Chair on a rotating 3 monthly basis
  - b) A co-ordinator
  - c) Minute secretary
  - d) Press officers
  - e) Treasurers (2)
- 3.4. No one party shall hold more than one of the above officerships. CONFIDENTIAL

- 3.5. No one individual shall hold an officership for more than an continuous period of 2 years.
- 3.6. The forum shall hold an Annual General Meeting at which it shall appoint its officers for the coming year.
- 3.7. The forum shall meet on a monthly basis.
- 3.8. There shall be provision for the holding of additional meetings as required.
- 3.9. The quorum for a meeting shall be no less than 5 parties present.

#### 4. Sub-Committees

- 4.1. There shall be provision for a number of sub-committees to deal with the following:
  - a) Fund raising
  - b) Organisation of seminars, conferences, etc
  - c) To formulate programmes of work for the forum
  - d) Public relations.
- 4.2. All recommendations of the sub-committees are subject to ratification

by the forum.

## 5. Affiliation to the NIWPF

- 5.1. Parties wishing to affiliate should apply in writing to the forum.
- 5.2. Affiliation to the forum is open to those parties willing to participate in the democratic process, who are committed entirely to peaceful means, and those who are willing to condemn the use of violence to achieve a political solution/settlement.
- 5.3. Affiliation to the forum will not diminish the individual rights of parties as autonomous, political entities.

#### 6. Changes to Constitution

- 6.1. Any party seeking changes to the constitution can do so by giving one month's written notice.
- 6.2. Any change will require a majority of two-thirds of all the affiliated parties.
