MACBRIDE: PROFESSIONAL LOBBYISTS IN MISSOURI AND DEBRASKA

Thank you for your letter of 10 May enclosing a copy of Chuck Gallagher's contract. You will wish to note that an amendment is required at paragraph 4 - line 4 should be amended to read "\$3,500 at the end of April 1994".

I should be grateful if you would arrange for us to receive from Chuck a schedule of activities covering the period 18 February-30 May 1994 as stipulated in paragraph 4 of his contract, to enable us to pay him in full. It would be particularly helpful if the schedule could include a note on any significant meetings including that with Governor Canaghan which he had during the course of his lobbying exercise.

I note what you have said about Jim Pappas' contract and look forward to receiving a copy from you in due course.

- 1. Would you please refer to your letter of 6 May about the contracts for Jim Pappas and Chuck Gallagher.
- / 2. I enclose a copy of the signed contract with Gallagher. I can confirm that the \$12,000 fee is for the current legislative session which finishes at the end of May.
 - 3. According to the terms of the contract you owe Gallagher \$8,000. I assume you will settle with him direct in the usual way.
 - 4. With regard to the contract for Jim Pappas, I will forward a copy of that when the signed version is to hand.

AGREEMENT



- 1. The following will constitute the sole legislative representation agreement between the BRITISH CONSULATE GEN Chicago (hereinafter referred to as the "Consulate") or its legal successor, and MR CHARLES V GALLAGHER.
- 2. Upon execution of this Agreement, the Consulate shall engage the services of CHARLES V GALLAGHER as an independent contractor with responsibility for providing legislative and governmental relations services. Such services shall include:
 - (a) Representation before the Missouri State Legislature and the State's administrative offices with respect to matters relating to employment practices in Northern Ireland.
 - (b) Reviewing, identifying and monitoring legislation and regulatory matters relating to the advancement of the MacBride Principles.
 - (c) Consulting regularly with members of the Consulate and reporting to the Consulate on important developments and hearings.
 - (d) Participation and attendance at briefings, meetings etc upon the request of the Consulate.



- 3. For such engagement, the Consulate shall pay CHARLES V

 GALLAGHER a fee of \$12,000 for the period 18 February 1994
 30 May 1994. This fee will include all out of pocket expenses.

 Any additional expenses relating to any extraordinary

 activity will also be met, providing that these are approved
 in advance by the Consulate.
- 4. Unless otherwise agreed, the fee of \$12,000 will be paid in three instalments ie:
 - \$5,000 at the end of March 1994
 - \$3,000 at the end of April 1994
 - \$3,500 at the end of May 1994

against a schedule of activities during the period, submitted by CHARLES V GALLAGHER to the Consulate.

5. It is understood that CHARLES V GALLAGHER will function as an independent contractor and will hold himself out as such and will be without authority to obligate the Consulate for indebtedness or other legal obligation.



- 6. CHARLES V GALLAGHER will comply with all United States

 Government reporting requirements which this representation

 may require.
- 7. CHARLES V GALLAGHER will be bound by a restrictive covenant which precludes him from representing any other client which would create a conflict of interest.
- 8. This Agreement may be terminated by either party upon thirty (30) days written notice for any reason.
- 9. The effective date of this Agreement is 18 February 1994 and it shall terminate on 30 May 1994.
