To ask the Secretary of State for Northern Ireland, on how many days and on what occasions in the last year the Union Flag was flown outside the (a) Northern Ireland Electricity Regional Offices on the Campsie Industrial Estate and (b) other offices of the NIE.

Information on the flying of the Union Flag by private companies is not held by Government. I understand that Northern Ireland Electricity issued a statement on 11 August 1998 setting out the company's policy on the display of flags and emblems.

BACKGROUND NOTE

- 1. Mr Kevin McNamara has tabled a Priority Written question seeking information on the number of occasions in the last year on which the Union Flag was flown outside the (a) Northern Ireland Electricity Regional Offices on the Campsie Industrial Estate (Londonderry) and (b) other offices of NIE.
- 2. It is not known what has prompted Mr McNamara's question. It may be linked to a statement in August by the Sinn Fein Deputy Mayor of Derry City Council Lynn Fleming querying the NIE policy of flying the Union Flag outside the Campsie office all year round. (Please see attached article from the Belfast Telegraph at Annex A.)
- 3. NIE issued a press statement in response to Councillor Fleming's comments (Annex B). The current policy is that the Union Flag and the Company Flag are flown all year round at the five major NIE work centres in Northern Ireland, namely Danesfort (HQ), Ballymena, Bangor, Campsie and Carn (Craigavon). This policy was adopted in 1988 in consultation with the relevant Trade Unions and following discussions with the then Fair Employment Agency. The company's Fair Employment practices, including the flying of the Union Flag, are kept under regular review in consultation with the Fair Employment Commission.
- 4. Guidance on the display of flags and emblems is contained in the Fair Employment Code of Practice. Following discussions between the relevant DED business areas, officials take the view that the provision of specific information on the flying of flags by a private company is not a matter for Government but for the company concerned. The suggested reply to Mr McNamara makes this point and draws attention to the NIE statement of 11 August 1998.
