# Proposal to provide Website Consultancy and Training to Equality Unit

21 February 2001

ARK (www ark ac. uk) provides a web based resource to facilitate easy access to a range of social and political material relevant to Northern Ireland. It originally contained three component parts: the CAIN website; the Northern Ireland Life and Times website and a new Online Research Bank. It has recently developed a new resource the Survey Results Service and has initiated plans to make other NI social datasets available on line.

The CAIN project manager, Dr. Martin Melaugh, was commissioned by CCRU in 1998 to develop a web presence for CCRU reports and other materials, and this is currently hosted at http://www.ccruni.gov.uk. The site has not been added to in some time and we are aware that some other CCRU material is available on other websites. At the time of the original proposal there were three main options proposed for the future development of the CCRU Internet site. These were:

- 1. The CCRU could ask for the transfer of the contents of the site to another server.
- 2. The CAIN project manager could provide training and access for CCRU staff to take over maintenance and development of the site on the CAIN server.
- 3. The CCRU could provide part funding of a CAIN post to maintain and develop the site.

There have been a number of important changes to the CAIN project since the original proposal (notably the loss of the CAIN research assistant) however these options would form the basis for part of the discussions suggested in this proposal.

Within the University of Ulster ARK is based within INCORE (www.incore.ulst.ac.uk) which among its many activities hosts an international web based Conflict Data Service.

This proposal will allow for two researchers from the Equality Unit to spend two and a half days at ARK/INCORE, University of Ulster, Magee Campus, Derry. The following programme of work is proposed:

### Day 1:

### Morning:

Arrival at INCORE, meeting with ARK UU team (Martin Melaugh, CAIN Project Manager, Gillian Robinson, Ark Director and Mike McCool, computing officer, ARK/INCORE), to agree workplan and establish the depth of existing web knowledge and special areas of interest.

Detailed work with Martin Melaugh on content and design of CAIN website. Particular issues CAIN has had to address with regard to the volume and quality of its content.

### Afternoon:

Continued work with Martin Melaugh focussing on CCRU materials and how the info made available via CAIN might be incorporated or linked into the new proposed Equality Unit website. Possible involvement of Mike McCool in the later stages of this discussion re transfer of content with special regard to software and hardware issues.

# Day 2:

# Morning:

Continued discussion with Martin Melaugh (and Mike McCool) on above.

## Afternoon:

Meeting with Gillian Robinson on overall ARK development and detail on Life and Times and the Online Research Bank.

# Day 3:

# Morning:

Conclude meetings with ARK team and move to meet with Liam O'Hagan, Research Officer responsible for INCORE CDS. This discussion will cover issues such as links at international level, a familiarisation with the INCORE website content noting especially the Country Guides and the Ethnic Conflict Research Digest which is an on-line publication. Mike McCool may also be involved in part of the discussions.

It should be noted that this proposal is only for advice/discussion on the issues raised above. Actual transfer of content from one site to another, should it be agreed, would involve further work, the exact amount being currently unknown. A separate proposal will be developed to do this should it be required.

If agreement is not reached concerning the dispute, difference or question(s) they shall, after written notice by either party to the contract to the other party, be referred to a single arbitrator agreed for that purpose or in default of such agreement within twenty-one (21) days, an arbitrator appointed at the request of either party or by the President of the Law of Northern Ireland. The decision of such arbiter shall be final and binding on the parties of the contract.
