1. Welcome and Introductions

2. Content and layout of Proposal

The proposed research was introduced by Ms Henry, Project Director. Dr Quirk and Mr Makin provided members with an outline of the proposed methodology.

3. Issues arising

Definition of victims

It was agreed that this is a contentious issue and one that could not be resolved by the current research. It was decided that the best way forward would be to recognise the issues surrounding defining victims of the Troubles but to try to be as inclusive as possible.

Access to victims

The issue of access to victims of the Troubles, particularly access to those with no affiliation to any victims groups, was highlighted. It was suggested victims could be approached via the VLU or the NI Memorial Fund. Mr Devitt suggested that Deloitte & Touche might wish to consider approaching the 6 Victims Support Workers in District Partnerships who could seek the consent of those victims of the Troubles who have no group affiliation to participate in the research.

Reference group

It was also suggested that a reference group, consisting of key players, ought to be established. Mr Devitt expressed some concern regarding how this might affect victims perceptions of the research. Dr Donnelly also pointed out that the research will have a high profile and has already attracted much attention including an Assembly Question. It was agreed that it might be useful to establish a reference group but that great care would need to be taken when doing so.

Representativeness of research

It was suggested that the representativeness of the research might be a potential issue. To reduce this as much as possible, Dr Donnelly suggested that it might be useful to gather attitudinal data from the general public, perhaps via the Omnibus or some other survey. It was pointed out that such a survey would affect the proposed time-scale.
