



FLAGS (NI) REGULATIONS 2000

- 1. Connor Murphy MLA has sought leave to apply for judicial review of the exercise of the Secretary of State's powers to make these Regulations under Article 3(1) of the Flags (NI) Order 2000. The application for leave will be heard in the High Court tomorrow morning. It seems likely that leave will be granted.
- 2. The grounds of challenge are:
 - as the power to make the Regulations is contained in an Order in Council made during suspension under the Northern Ireland Act 2000, it is invalid and improper to exercise the power during restoration (this overlooks the Northern Ireland Act 2000 (Modification) Order 2000, which expressly saves Orders in Council made during suspension);
 - the Regulations are inconsistent with sections 75 and 76 of the Northern Ireland Act (promotion of equality of opportunity and discrimination on the ground of religious belief or political opinion);
 - the Regulations are inconsistent with the GFA;
 - the Regulations are incompatible with the Applicant's ECHR rights and the Human Rights Act 1998;
 - in making the Regulations, the Secretary of State has failed to exercise his discretion properly, that his decision is unlawful, unreasonable and unfair, and that he has acted in bad faith and partially; and
 - acted contrary to the legitimate expectation (of whom?) that the policy on flags would be decided by the locally elected representatives in Northern Ireland.
- 3. I will let you know if leave is granted.
