Purpose

Arrangements for 5 October

3. It had been expected that these new arrangements would come into play on 5 October (with no Ministerial meeting in w/c 28 September because of the Party Conference). However on that date only the Secretary of State and Mr Murphy will be available, since Mr Ingram is in the States, Mr McFall on leave and Lord Dubs in the House of Lords on the NI Bill. I should be grateful to know the Secretary of State's view on whether a meeting should be held that day.

Liaison Meeting with First and Deputy First Ministers

- 4. The First and Deputy First Ministers have indicated at recent Liaison meetings that
 - (i) a Liaison meeting should be held each week (Mondays 3pm); in their absence, they can be represented by special advisers or party spokespersons,
 - (ii) they wish to structure the meetings, so that the most significant items of business across NI Departments are considered in the immediate future, with less vital matters being set aside at present.
 - (iii) papers should be provided to them as far in advance of a discussion as possible (minimum 4 days) to enable them to be adequately considered.
 - (iv) papers should set out clearly the timescales including when and what decisions/actions are required both by Ministers/Departments and the First and Deputy First Ministers.
